

Equal Employment Opportunity Statement

Forest Electric Corp. NJ has an enduring commitment to the concept and practice of equal employment opportunity and affirmative action as well as to affirming the value of diversity and promoting a workplace free from discrimination.

It is the policy of Forest Electric Corp.
